INVITATION OF BIDS FOR FRONT END COLLECTION AND TRANSPORTATION OF MUNICIPAL SOLID WASTE FOR ZONE SOUTH (DMC SOUTH AREA) KARACHI, PAKISTAN

INTERNATIONAL COMPETITIVE BIDDING

Sindh Solid Waste Management Board (SSWMB), established under Law to manage Solid Waste in Karachi and other districts of Sindh Province, has sole rights on all kinds of solid wastes within the limits of all municipal councils and has authority to grant permissions to establish appropriate waste collection, transportation, recycling, composting and energy generation projects.

Karachi is the largest mega polis of Pakistan and the capital of Sindh province with a population of about twenty two million generating approximately 12,000 tons of waste per day. The City is divided into six districts each having a separate District Municipal Corporation. South Zone is one of these districts.

SSWMB is in the process of establishment of **Integrated Municipal Solid Waste Front End Collection, sweeping & Transportation Project in Karachi.**

SSWMB hereby invites sealed bids from interested National and International firms or Consortium / Joint Ventures, having sound experience in the field of Municipal Solid Waste Management.

The successful firm will be investing in and managing the entire front end collection and transportation project including:

- Door to door collection of garbage & revamping of bin system
- Sweeping of roads, streets, lanes, footpaths, medians and open spaces
- Washing of important roads as when required
- Lifting and transportation of MSW from dustbin sites & collection points to designated GTS
- Establishment of Scientific Monitoring and Tracking of entire system i.e. vehicles, sanitary staff, assets etc.
- Establishment of Complaint Management System, and
- Community Awareness Programme and its implementation.

All interested bidders are required to be registered with relevant tax authorities of Islamic Republic of Pakistan. However in case of foreign firms, bidding alone or as leading firm in the Joint Venture or Consortium, they will be given appropriate time to get registered with PEC and relevant tax authorities after issuance of the Letter of Intent (LOI).

The procurement process shall be SINGLE STAGE - TWO ENVELOPE PROCEDURE and governed by Rule 46 (2) of Sindh Public Procurement Rules 2010. (Amended 2013)

Interested companies can download necessary documents including eligibility criteria upon payment through cross cheque of Pak Rs.5000 or US\$ 50 in favor of Sindh Solid Waste Management Board from the date of publication of this notice to 29th September 2015 from the office of Assistant Director (Finance) SSWMB during office hours or may also be downloaded from the website www.pprasindh.gov.pk or www.sswmb.gos.pk

The Bids must clearly state "PROPOSAL FOR FRONT END COLLECTION AND TRANSPORTATION OF MUNICIPAL SOLID WASTE FOR ZONE SOUTH (DMC SOUTH AREA) KARACHI, PAKISTAN" and must be delivered in English language under sealed envelope by hand or through courier not later than 1500 hrs PST on 30th September 2015 and the same shall be opened by the Procurement Committee in presence of the representatives of bidders at 1600 hrs PST on the same day.

Sindh Solid Waste Management Board will not be responsible for any cost or expenses incurred by bidding firms and reserve the right to terminate the procurement process at any time subject to relevant provision of SPP Rules, 2010 (Amended 2013).
