- 1. The Government of Sindh has received financing from the World Bank toward the cost of the Solid Waste Emergency & Efficiency Project (SWEEP) and intends to apply part of the proceeds for consulting services.
- 2. The main objective of the Consulting Services ("the Services") is to prepare a full-scale ESIA and ESMP for the construction, operation and closure of the new landfill cell and the six transfer stations, in accordance with the provisions of the updated ESMF prepared for the project, and a comprehensive Resettlement Plan (RP) for the six transfer stations and Jam Chakro Landfill site based on the updated RF. - 3. The assignment includes consultancy services over a one-year (extendable) period. The consultants would be required to field a multi-disciplinary team of senior, mid-and junior-level professional staff and support staff. A core team will be assigned to work with PD PIU SWEEP at Karachi.
- 4. The Project Implementation Unit, Solid Waste Emergency & Efficiency Project (SWEEP) now invites consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are as under:

No.	Criterion
1.	Track Record : Corporate Capacity (Core business, number of offices and years in same business, years in Urban sector).
	The minimum track record of the Firm is required (10) years.
2.	General experience: Providing comparable services in Environmental and Social Impact Assessment & Preparing Environmental and Social Management Plan. Five (05) projects during the last ten (10) years are required.
3.	Relevant experience: Conducting three (03) projects of Environmental and Social Impact Assessment & Preparing Environmental and Social Management Plan for the Construction of a New Landfill Cell and Transfer Stations during the last ten (10) years.
4.	Overall managerial capacity (Core managerial and technical staff) Experts with relevant experience in Conducting Environmental and Social Impact Assessment & Preparing Environmental and Social Management Plans across the globe (CVs will not be evaluated at this stage)

- 5. The attention of interested Consultants is drawn to the provisions of 'Conflict of Interest' under Section 3.17 of the World Bank's Procurement Regulations for Borrowers for Goods, Works, Non-Consulting and Consulting Services dated November 2020.
- 6. Consultants may associate with other firms to enhance their qualifications but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, the lead partner in the joint venture shall be fully responsible for the entire contract, if selected.
