In response to Pre-Bid Meeting held on 13th May 2025, the following amendments have been made through Addendum-I to Request for Proposal dated 1st May 2025

FOR Bidders must provide performance certificate from the employer in performing similar services or sanitation services for all contracts during the last 3 years. The performance under the contracts must be of Integrated Municipal Solid Waste with at least 1 operational Material Recovery Facility (MRF) of 100 tons (minimum semi-automatic facility). If a Bidder has poor performance in any of the certificates, the Bidder will be dis-qualified and will also be disqualified if the Bidder intentionally misrepresents or hides such projects where the performance has been poor. The Employer may require further information in connection with the performance certificates.

Bidders must provide performance certificate from the employer in performing similar services or sanitation services for all contracts during the last 3 years. The performance under the contracts must be of Integrated Municipal Solid Waste. If a Bidder has poor performance in any of the certificates, the Bidder will be dis-qualified and will also be disqualified if the Bidder intentionally misrepresents or hides such projects where the performance has been poor. The Employer may require further information in connection with the performance certificates.
